



## Starting A New Business in San Bruno

**BUSINESS TAX CERTIFICATE** 

All businesses operating within the city limits of San Bruno are required to have a City Business Tax Certificate

PLANNING DEPARTMENT

For questions concerning zoning, use conformance forms or signs.

**BUILDING DEPARTMENT** 

For remodeling or questions concerning building codes.

**FICTITIOUS BUSINESS NAME** 

If a business name does not contain your first & last name it is considered fictitious and must be cleared through the County.

**SELLERS PERMIT/RESALE NUMBER** 

For businesses selling tangible property which is subject to State

Sales & Use Tax.

**ENVIRONMENTAL BOARD OF HEALTH** 

For businesses selling food, restaurants, etc.

**CALIFORNIA FOOD & DRUG DEPT.** 

Issues permits to Food Manufactures/Wholesalers

DEPT. OF ALCOHOLIC BEVERAGE CONTROL

For all businesses selling or serving alcoholic beverages.

**CUSTOM SERVICES** 

For businesses importing and exporting goods.

**COMMUNITY CARE LICENSING** 

For family day care, day care centers, residential care homes.

CONTRACTORS STATE LICENSE BOARD

Call to determine whether license is needed.

STATE OF CALIFORNIA EMPLOYMENT DEVELOPMENT DEPT.

For payroll I.D. number & to comply with State requirements regarding withholding or employee taxes & insurance.

**INTERNAL REVENUE SERVICE** 

For federal identification number, filing self employment tax

returns, employee taxes, etc.

**CALIFORNIA DEPT. OF INDUSTRIAL RELATIONS** 

For workers compensation insurance.
